Your privacy is important to Unexpected Books. By visiting and using this website, you agree and consent to the following Privacy Policy governing the collection and use of personally identifiable and other information by Unexpected Books.

Unexpected Books may collect information from you when you voluntarily sign up for emails or free information, submit comments on this website, fill out any type of form, or otherwise contact Unexpected Books via an online form or email. The information collected may include your name and/or email address. You are not required, however, to provide any personally identifiable information to merely access or visit this website.

Unexpected Books collects such information in order to send emails, oversee contests and promotions, and improve website performance and customer service. Unexpected Books’ systems may also automatically gather information about the areas you visit and about the links you may select from within Unexpected Books to other areas of the Internet.

However, Unexpected Books may choose to release personal information to protect users or the general public, or to otherwise comply with legal obligations.
